Thanks — I'm actually relieved to know that you haven't received a reply either. At least the journal is behaving consistently.

Now that you are no longer the ms editor, AM is apparently following the paths well-trodden by the other journals to which I've submitted the ms.

Journals have either declined to review at all, typically notifying me after I queried them following their weeks of silence; editors decline review offering some shallow objection and then refuse to countenance a response, or; (third path) reject following negative reviews that are shown to be obviously incompetent. Sometimes items two and three both occur together.

All of these paths represent violations of editorial responsibility, and often of professional ethics.

If Ms. Rana Ali does not reply next week, I plan to send in a formal request to un-submit the manuscript, so that I can send it elsewhere. If you like, I will cc you on that email; or bcc if you prefer.

Question for you: in round one at AM did you recognize that review #1 and review #2 were incompetent?
